- IX. Old Business Staffing Shortage impacting patient numbers Dentist nationwide shortage continues to impact us.
- X. Review of Grants Changes, Updates and Revisions
 - a. HRSA Grant H8L51992 FY 2023 Bridge Access Program NOA received in the amount of \$21,455. This is for the purchase COVID vaccine and testing supplies. This was awarded to us by HRSA, we did not have to write for it.
 - b. MCPHD Executive Team wrote for two grants all internally and were awarded both of them. We had no expense from outside grant writing consultants.

- HRSA Grant H2E50205, Health Center Program Service Expansion -School Based Service Sites (SBSS), in the amount of \$250,000 each year for two years. This was a competitive grant and MCPHD was 1 of 3 awards given in Illinois. NOA received on this award.
- IDPH Grant Child/Adolescent Preventing Adverse Childhood Experiences (ACES) post COVID grant (PACES-PC) MCPHD received \$200,000 and was only 1 of 11 counties chose to receive this grant.

 - a. Columbia versus Cincinnati, \$4900 less with Cincinnati with same coverage. If we increase deductible on wind/hail from \$5k to \$10k, Cincinnati will guarantee same rate for 3 years.
 - b. Motion to increase wind/hail deductible from \$5k to \$10k and lock premium for 36 months with Cincinnati. Mike motioned. Chaz second. Motion carried.
- f. Sign waiver for terrorism coverage and remove Commercial Property Expanded Coverage (XC) Plus Endorsement
 - a. Motion to sign waiver and remove Commercial Property Expanded Coverage (XC) Plus Endorsement. Nikki motioned. Mike second. Motion carried.
- g. Remove Inland Marine Policy no longer needed. Previous administrator must have had it for construction at some point in time.
 - a. Motion to remove Inland Marine Policy. Nikki motioned. Mike seconded. Motion carried.

- i. Encounter Rate Increase IPHCA lobbied for an increase in encounter reimbursement for Community Health Centers and were successful.

 - a. We are paying \$400-500 monthly in credit card fees by using this registration system, however the convenience to the patients to pay during registration has helped with patient pay fees.
